Terms of Use for SANZE Demo Site

1. Purpose of Use

- (1) The User may use the demo site free of charge under the terms and conditions set forth in these Terms of Use during the period that Lotus System Viet Nam Company, Ltd. (1) The User may use the demo site free of charge under the terms and conditions described in this Terms of Use during the period when the demo site is open to the public by Lotus System Viet Nam Company, Ltd.
- Users may use and edit sample data on the demo site, and create and register new data.
 (2) Users may use and edit sample data on the Demo Site, create and register new data, etc. However, deletion of data shall be limited to data created and registered on the Demo Site by the Users themselves. LOTUS reserves the right to delete any data registered on the demo site at its sole.

2. ID and Password for Demo Site

Users shall use the ID and password common to all Users (hereinafter referred to as "ID for Demo Site") issued by LOTUS for the purpose of using SANZE on the Demo Site. The User may use the demo site ID and password (hereinafter referred to as "Demo Site ID, etc.") issued by LOTUS for the purpose of using SANZE on the Demo Site only for the purpose of the preceding paragraph. Any use other than for the purposes of the preceding paragraph, such as commercial use by the User, is not permitted.

3. Prohibited Matters

The user may not transfer, lend, resell, or pledge as collateral any of the rights granted hereunder. The user may not lend or license the demo site ID, etc. to any third party. You hereby acknowledge that the only rights granted hereunder are the trial rights of SANZE, and that LOTUS reserves all rights not granted in these Terms of Use.

4. Limitation of Warranty

- (1) Users shall not register any information on the Demo Site that could be compromised if leaked, damaged, or lost. LOTUS shall not be liable for any damage or loss incurred by the User or any third party as a result of the leakage or corruption of all or any part of the data registered by the User when using the Demo Site.
- (2) LOTUS shall not be liable for any damage or loss incurred by the User or any third party who accesses the Demo Site and is infected with a virus, hacked, or otherwise harmed.
- (3) LOTUS does not warrant that the functions of SANZE on the Demo Site will meet your requirements, that they will operate properly, or that bugs or other problems will not exist, or that if they do exist, they will be corrected.

5. Suspension or Discontinuance of Service

- (1) LOTUS reserves the right to suspend or terminate the service on the Demo Site in the event of any of the following events.
